TERMS AND CONDITIONS OF KEYCARD ONLY MEMBERSHIP

I, _____ wish to obtain Supra keycard service through the REALTOR® Association of NorthWest Chicagoland (RANWC). I agree to the following:

1. I will pay an annual GE Security-Supra ActiveKey lease fee and sign appropriate paperwork. The annual fee will be due on June 30th of every year.
2. I understand that my contract with GE Security/Supra will continue through 2013, and an annual cost of living adjustment may be made to next year's lease fee. Termination of lease before 2013 is available if equipment is returned and cancellation complete.
3. I understand that the ActiveKey is leased from GE Security-Supra via RANWC, and I will return the key if I resign as a REALTOR® member.
4. Upon signing this agreement I will pay RANWC \$30 for their 2008 annual keycard fee. This will keep me current with RANWC through September 30, 2009.
5. I understand I cannot share my ActiveKey with anyone, or I will be assessed a \$1,000 fine.
6. I understand that GE Security-Supra i-Boxes can be purchased for \$105 plus tax (price subject to change)

ActiveKey Usage Agreement

- 1. UNAUTHORIZED USE OF ENTRY CARD**
Allowing anyone other than the Cardholder to use the entry card will Result in a fine of \$1,000 for EACH OCCURRENCE.
- 2. CONFIDENTIALITY OF PIN CODES**
Affixing PIN codes to the Entry Card or keeping a PIN code with the entry card will result in a fine of \$1,000
- 3. FAILURE TO RETURN LISTING KEY(S)**
Should the member who acquires a key according to the Electronic KeyBox system fail to return the key(s) after a showing of a home to the appropriate lock box, the following penalties will be enforced: the penalty for the first offense is to watch the Lock Box Training video; the second offense is a \$250 fine; the third offense is a \$1,000 fine plus suspension of keycard privileges for an amount of time as determined by the Board of Directors.
